Ordered, That at 12 p.m. on Tuesday, July 15, 2014, the Senate proceed to executive session and vote on the motions to invoke cloture on the nominations of: Norman C. Ordered further, That there be two minutes for debate prior to each vote; that if any nomination is confirmed, the motion to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's action, and the Senate then resume legislative session.
