UNANIMOUS CONSENT AGREEMENT

Ordered, That at 5:30 p.m. on Monday, July 21, 2014, the Senate proceed to executive session to vote on confirmation of the nomination of Julie E. Carnes, of Georgia, to be United States Circuit Judge for the Eleventh Circuit.

Ordered further, That following the disposition of the Carnes nomination, the Senate remain in executive session to consider the nominations of: Michael Anderson Lawson, of California, for the rank of Ambassador during his tenure of service as Representative of the United States of America on the Council of the International Civil Aviation Organization; and Eunice S. Reddick, of the District of Columbia, a Career Member of the Senior Foreign Service, Class of Minister-Counselor, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Niger.

Ordered further, That there be two minutes for debate equally divided between the two Leaders, or their designees, prior to each vote; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nominations in the order listed; that any roll call votes, following the first in the series, be 10 minutes in length.
