Ordered, That at 2:45 p.m. on Tuesday, July 29, 2014, the Senate proceed to executive session to vote on confirmation of the nomination of Robert Alan McDonald, of Ohio, to be Secretary of Veterans Affairs.

Ordered further, That the time from 12 p.m. until 12:30 p.m. and from 2:15 p.m. until 2:45 p.m. on Tuesday, July 29, 2014, be equally divided in the usual form for debate on the McDonald nomination.

Ordered further, That following consideration of the McDonald nomination, the Senate remain in executive session and proceed to consideration of the following nominations:

Larry Edward Andre, Jr., of Virginia, a Career Member of the Senior Foreign Service, Class of Counselor, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Islamic Republic of Mauritania;

Michael Stephen Hoza, of Washington, a Career Member of the Senior Foreign Service, Class of Minister-Counselor, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Cameroon; and

Joan A. Polaschik, of Virginia, a Career Member of the Senior Foreign Service, Class of Counselor, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the People's Democratic Republic of Algeria.
