UNANIMOUS CONSENT AGREEMENT

George C. Hanks, Jr. (Cal. No. 24)

Ordered, That at 5 p.m. on Monday, April 20, 2015, the Senate proceed to executive session to consider the nomination of George C. Hanks, Jr., of Texas, to be United States District Judge for the Southern District of Texas.

Ordered further, That there be 30 minutes for debate equally divided in the usual form; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nomination and that following disposition of the nomination the motion to reconsider be considered made and laid upon the table; that no further motion be in order to the nomination; that the President be immediately notified of the Senate's action and the Senate then resume legislative session.
