Ordered, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to executive session to consider individually either of the following nominations: Brian R. Martinotti, of New Jersey, to be United States District Judge for the District of New Jersey; and Robert F. Rossiter, Jr., of Nebraska, to be United States District Judge for the District of Nebraska.

Ordered further, That there be 30 minutes for debate only on each nomination equally divided in the usual form; that upon the use or yielding back of time on the respective nomination, the Senate vote without intervening action or debate on the nomination. (*Jun. 21, 2016.*)
