UNANIMOUS CONSENT AGREEMENTS

Rex W. Tillerson (Cal. No. 2)

Ordered, That at 5 p.m. on Monday, January 30, 2017, the Senate proceed to executive session to resume consideration of the nomination of Rex W. Tillerson, of Texas, to be Secretary of State, and that there be 30 minutes of debate, equally divided in the usual form.

Ordered further, That notwithstanding Rule XXII, the vote on the motion to invoke cloture occur at 5:30 p.m. on Monday, January 30, 2017.

Ordered further, That with respect to the vote on the motion to invoke cloture on the nomination, the mandatory quorum required under Rule XXII be waived. (*Jan. 24, 2017.*)

Elaine L. Chao (Cal. No. 4)

Ordered, That at 12 noon on Tuesday, January 31, 2017, notwithstanding Rule XXII, the Senate proceed to executive session for consideration of the nomination of Elaine L. Chao, of Kentucky, to be Secretary of Transportation.

Ordered further, That there be 20 minutes of debate on the nomination, equally divided in the usual form, and that following the use or yielding back of time, the Senate vote on the nomination with no intervening action or debate; that if confirmed, the motion to reconsider be considered made and laid upon the table; the President be immediately notified of the Senate's actions, and that no further motions be in order.
