UNANIMOUS CONSENT AGREEMENT

William J. Emanuel (Cal. No. 176)

Ordered, That following Leader remarks on Monday, September 25, 2017, the Senate proceed to executive session and resume consideration of the nomination of William J. Emanuel, of California, to be a Member of the National Labor Relations Board for the term of five years expiring August 27, 2021, with the time until 5:30 p.m. equally divided between the two Leaders or their designees.

Ordered further, That at 5:30 p.m., all post-cloture time be expired and the Senate vote on confirmation of the nomination with no intervening action or debate, and if confirmed, the motion to reconsider be considered made and laid upon the table, the President be immediately notified of the Senate's actions, and the Senate then resume legislative session.
