UNANIMOUS CONSENT AGREEMENT

Joseph Balash (Cal. No. 321)

Ordered, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to executive session for consideration of the nomination of Joseph Balash, of Alaska, to be an Assistant Secretary of the Interior.

Ordered further, That there be 1 hour of debate on the nomination equally divided in the usual form, and that following the use or yielding back of time, the Senate vote on confirmation of the nomination with no intervening action or debate, and that if confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions.
