Ordered further, That with respect to the motion to invoke cloture on the nomination of James Randolph Evans, of Georgia, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to Luxembourg, the mandatory quorum required under Rule XXII be waived.

Ordered further, That if cloture is invoked on the Evans nomination, the time until 1:45 p.m. be equally divided in the usual form and at 1:45 p.m. the Senate vote on the nomination.

Ordered further, That if any of the nominations are confirmed, the motions to reconsider be considered made and laid on the table and the President be immediately notified of the Senate's actions. (*May 17, 23, 2018.*)

Ordered, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to executive session for the consideration of the nomination of Kenneth L. Marcus, of Virginia, to be Assistant Secretary for Civil Rights, Department of Education.
