## UNANIMOUS CONSENT AGREEMENT

### House Message to Accompany H. R. 302

*Ordered*, That notwithstanding Rule XXII, and as if in Legislative Session, with respect to the House Message to accompany H. R. 302, an Act to provide protections for certain sports medicine professionals who provide certain medical services in a secondary State, the Senate remain in executive session and the post-cloture time continue to run as otherwise under the Rule; provided, that at 12:00 noon on Wednesday, October 3, 2018, all post-cloture time expire and the Senate vote, as if in legislative session, on the motion to concur; further, that all time during Leader time and recesses count post-cloture. (*Sept. 28, Oct. 1, 2018.*)
