Ordered, That following Leader remarks on Wednesday, June 5, 2019, the Senate proceed to executive session and resume consideration of the nomination of David Schenker, of New Jersey, to be an Assistant Secretary of State (Near Eastern Affairs).

Heath P. Tarbert, of Maryland, to be a Commissioner of the Commodity Futures Trading Commission for a term expiring April 13, 2024.

Ordered further, That if cloture is invoked on those nominations, the confirmation votes occur at a time to be determined by the Majority Leader in consultation with the Democratic Leader.

Ordered further, That if confirmed, the motions to reconsider be considered made and laid on the table and the President be immediately notified of the Senate's actions. (*May 23, Jun 3, 4, 2019.*)
