UNANIMOUS CONSENT AGREEMENT

Gen. Mark A. Milley (Cal. No. 375)

Ordered, That at 1:45 p.m. on Thursday, July 25, 2019, the Senate proceed to executive session for the consideration of the nomination of Gen. Mark A. Milley for appointment as Chairman of the Joint Chiefs of Staff and appointment in the United States Army to the grade of general.

Ordered further, That the Senate vote on the nomination with no intervening action or debate; that if confirmed, the motion to reconsider be considered made and laid upon the table with no intervening action or debate, that no further motions be in order, and the President be immediately notified of the Senate's actions, and the Senate then resume legislative session.
