Ordered, That following Leader remarks on Tuesday, September 15, 2020, the Senate proceed to executive session to resume consideration of the nomination of Mark C. Scarsi, of California, to be United States District Judge for the Central District of California.

Ordered further, That if cloture is invoked on the Robinson nomination, the post-cloture time expire at a time to be determined by the Majority Leader in consultation with the Democratic Leader on Wednesday, September 16, 2020.

Ordered further, That if any of the nominations are confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions.
