UNANIMOUS CONSENT AGREEMENT

Antony John Blinken (Cal. No. 3)

Ordered, That upon the conclusion of morning business on Tuesday, January 26, 2021, the Senate proceed to executive session to consider the nomination of Antony John Blinken, of New York, to be Secretary of State.

Ordered further, That the time until 12 noon be equally divided between the two Leaders or their designees, with the Senator from New Jersey (Mr. Menendez) be permitted to speak for up to 5 minutes, and that at 12 noon, the Senate vote without intervening action or debate on the nomination; that if confirmed, the motion to reconsider be considered made and laid upon the table, the President be immediately notified of the Senate's actions.
