UNANIMOUS CONSENT AGREEMENT

Ordered, That upon the conclusion of morning business on Thursday, October 21, 2021, the Senate proceed to executive session to resume consideration of the nomination of Tana Lin, of Washington, to be United States District Judge for the Western District of Washington.

Ordered further, That with respect to the motions to invoke cloture on the following nominations, the mandatory quorum calls required under Rule XXII be waived:

Tana Lin, of Washington, to be United States District Judge for the Western District of Washington;
Douglas L. Parker, of West Virginia, to be an Assistant Secretary of Labor; and
Myrna Perez, of New York, to be United States Circuit Judge for the Second Circuit.

Ordered further, That notwithstanding the provisions of Rule XXII, at 10:30 a.m., the Senate vote on the motions to invoke cloture on the Lin, Parker, and Perez nominations in that order.

Ordered further, That if cloture is invoked on any of the nominations, all post-cloture time be considered expired at 1:45 p.m.

Ordered further, That if cloture is invoked on the Lin nomination, the confirmation vote occur at 1:45 p.m.

Ordered further, That if the Lin nomination is confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions.

Ordered further, That if cloture is invoked on the Parker or Perez nominations, the confirmation votes begin at 5:30 p.m. on Monday, October 25, 2021. (*Oct. 19, 20, 2021.*)
