Ordered, That following the conclusion of morning business on Thursday, May 4, 2023, the Senate proceed to executive session to resume consideration of the nomination of LaShonda A. Hunt, of Illinois, to be United States District Judge for the Northern District of Illinois, post-cloture.

Ordered further, That at 11:30 a.m., all time on the Hunt nomination be considered expired.

Ordered further, That with respect to the motions to invoke cloture on the nominations of Colleen Joy Shogan, of Pennsylvania, to be Archivist of the United States and Geeta Rao Gupta, of Virginia, to be Ambassador at Large for Global Women's Issues, the mandatory quorum calls required under Rule XXII be waived.

Ordered further, That following the cloture vote on the Shogan nomination, notwithstanding Rule XXII, the Senate resume consideration of the Gupta nomination with the time until 1:45 p.m. equally divided between the two Leaders or their designees.

Ordered further, That at 1:45 p.m., the Senate vote on the motion to invoke cloture on the Gupta nomination.
