## UNANIMOUS CONSENT AGREEMENT

*Ordered,* That following the conclusion of morning business on Thursday, July 13, 2023, the Senate proceed to executive session to resume consideration of the nomination of Kalpana Kotagal, of Ohio, to be a Member of the Equal Employment Opportunity Commission for a term expiring July 1, 2027.

*Ordered further,* That, notwithstanding Rule XXII, cloture having been invoked on the nomination of Kalpana Kotagal, of Ohio, to be a Member of the Equal Employment Opportunity Commission for a term expiring July 1, 2027, all post-cloture time be considered expired at 11:30 a.m.

*Ordered further,* That with respect to the motions to invoke cloture on the nominations of David M. Uhlmann, of Michigan, to be an Assistant Administrator of the Environmental Protection Agency and Rachel Bloomekatz, of Ohio, to be United States Circuit Judge for the Sixth Circuit, the mandatory quorum calls required under Rule XXII be waived.

*Ordered further,* That if cloture is invoked on the Uhlmann nomination, all post-cloture time be considered expired and the vote on confirmation be at a time to be determined by the Majority Leader in consultation with the Republican Leader.

*Ordered further,* That following the cloture vote on the Uhlmann nomination, the Senate proceed to legislative session and be in a period of morning business.

*Ordered further,* That at 1:45 p.m., the Senate proceed to executive session and vote on the motion to invoke cloture on the Bloomekatz nomination.

*Ordered further,* That if any nominations are confirmed during Thursday's session, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. (*Jul. 10, 12, 2023.*)
