## UNANIMOUS CONSENT AGREEMENT

*Ordered,* That following the conclusion of morning business on Wednesday, September 6, 2023, the Senate proceed to executive session to resume consideration of the nomination of Philip Nathan Jefferson, of North Carolina, to be Vice Chairman of the Board of Governors of the Federal Reserve System for a term of four years, post-cloture.

*Ordered further,* That at 11:30 a.m., all post-cloture time be considered expired on the Jefferson nomination and the Senate vote on confirmation of the nomination.

*Ordered further,* That with respect to the motions to invoke cloture on the following nominations, the mandatory quorum calls required under Rule XXII be waived:

Gwynne A. Wilcox, of New York, to be a Member of the National Labor Relations Board for the term of five years expiring August 27, 2028;

Lisa DeNell Cook, of Michigan, to be a Member of the Board of Governors of the Federal Reserve System for a term of fourteen years from February 1, 2024;

Adriana Debora Kugler, of Maryland, to be a Member of the Board of Governors of the Federal Reserve System for the unexpired term of fourteen years from February 1, 2012; and

Anna M. Gomez, of Virginia, to be a Member of the Federal Communications Commission for a term of five years from July 1, 2021.

*Ordered further,* That following the cloture vote on the Wilcox nomination, the Senate recess until 2:15 p.m. to allow for the weekly caucus meetings.

*Ordered further,* That if cloture is invoked on the Wilcox nomination, the Senate vote on confirmation of the Wilcox nomination at 2:15 p.m.

*Ordered further,* That if cloture is invoked on the Cook nomination, at 5:15 p.m. all post-cloture time be considered expired and the Senate vote on confirmation of the nomination.

*Ordered further,* That if any nominations are confirmed, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. (*Jul. 27 and Sep. 5, 2023.*)
