Ordered, That upon the conclusion of morning business on Tuesday, March 12, 2024, the Senate proceed to executive session to resume consideration of the nomination of Jasmine Hyejung Yoon, of Virginia, to be United States District Judge for the Western District of Virginia, post-cloture.

Ordered further, That at 11:30 a.m., that all time on the Yoon nomination be considered expired.

Ordered further, That with respect to the motions to invoke cloture on the nominations of Sunil R. Harjani, of Illinois, to be United States District Judge for the Northern District of Illinois and Melissa R.
