## UNANIMOUS CONSENT AGREEMENTS

*Ordered*, That upon the conclusion of morning business on Wednesday, March 20, 2024, the Senate proceed to executive session to resume consideration of the nomination of Edward Sunyol Kiel, of New Jersey, to be United States District Judge for the District of New Jersey.

*Ordered further*, That at 12 noon, the cloture motions with respect to the Kiel nomination and the nomination of Eumi K. Lee, of California, to be United States District Judge for the Northern District of California ripen.

*Ordered further*, That with respect to the motions to invoke cloture on the Kiel and Lee nominations, the mandatory quorum calls required under Rule XXII be waived.

*Ordered further*, That following the cloture vote on the Kiel nomination, the Senate recess until 2:15 p.m. to allow for the weekly caucus meetings.

*Ordered further*, That if cloture is invoked on the Kiel nomination, all time be considered expired at 2:15 p.m.

*Ordered further*, That if cloture is invoked on the Lee nomination, all time be considered expired at 5:15 p.m.

*Ordered further*, That if any nominations are confirmed during Wednesday's session, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. (*Mar. 14, 19, 2024.*)
