UNANIMOUS CONSENT AGREEMENTS

Ordered, That upon the conclusion of morning business on Thursday, March 21, 2024, the Senate proceed to executive session to resume consideration of the nomination of Jose Javier Rodriguez, of Florida, to be an Assistant Secretary of Labor.

Ordered further, That at 11:30 a.m. the motion to proceed to the vote by which cloture was not agreed to on the Rodriguez nomination be agreed to; the motion to reconsider the failed cloture vote be agreed to; and the Senate vote on the motion to invoke cloture on the Rodriguez nomination, upon reconsideration.

Ordered further, That with respect to the motion to invoke cloture on the nomination, the mandatory quorum call required under Rule XXII be waived.

Ordered further, That if cloture is invoked, all time be considered expired at 2 p.m.

Ordered further, That following the confirmation vote, the Senate resume legislative session for the consideration of S.J. Res. 62.

Ordered further, That upon disposition of the joint resolution, the Senate resume executive session and resume consideration of the nomination of Leon Schydlower, of Texas, to be United States District Judge for the Western District of Texas.

Ordered further, That if any nominations are confirmed during Thursday's session, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. (*Nov. 16, 2023 and Mar. 20, 2024.*)
