*Ordered further,* That at 11:30 a.m., all time be considered expired on the Bazis nomination.

*Ordered further,* That with respect to the motions to invoke cloture on the nominations of Robert J. White, of Michigan, to be United States District Judge for the Eastern District of Michigan and Ann Marie McIff Allen, of Utah, to be United States District Judge for the District of Utah, the mandatory quorum calls required under Rule XXII be waived.
