Ordered, That following the disposition of H.J. Res. 109 on Thursday, May 16, 2024, the Senate proceed to executive session to consider the nomination of Camela C. Theeler, of South Dakota, to be United States District Judge for the District of South Dakota.

Ordered further, That there be 2 minutes for debate equally divided in the usual form on the nomination.

Ordered further, That upon the use or yielding back of time, the Senate vote without intervening action or debate on the nomination.

Ordered further, That if confirmed, the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's actions.

Ordered further, That upon disposition of the Theeler nomination, the Senate resume consideration of the nomination of Seth Robert Aframe, of New Hampshire, to be United States Circuit Judge for the First Circuit.

Ordered further, That at 1:45 p.m., the cloture motion with respect to the Aframe nomination ripen.

Ordered further, That with respect to the motion to invoke cloture on the Aframe nomination the mandatory quorum call required under Rule XXII be waived. (*May 7, 9, 14, 15, 2024.*)
