Ordered, That upon the conclusion of morning business on Tuesday, June 4, 2024, the Senate proceed to executive session to resume consideration of the nomination of Christopher T. Hanson, of Michigan, to be a Member of the Nuclear Regulatory Commission for the term of five years expiring June 30, 2029, post-cloture.

Ordered further, That at 11:30 a.m., all post-cloture time on the Hanson nomination be considered expired.

Ordered further, That with respect to the motions to invoke cloture on the following nominations, the mandatory quorum calls required under Rule XXII be waived:
